	(c) Performance record of the institution evaluated by a recognized agency in last 3 years. The evaluating institution should be an accredited organization specialized in evaluation. If, no evaluation has been done in past three years, no marks will be awarded. Executive Summary of the evaluation report to be enclosed. 	(d) The number of projects implemented by the organization in the region/area/locality similar cultural environment where it intends to implement the projects under this scheme.
